For nearly 100 years, our mission has been to provide stability, opportunity, and hope to children and families in poverty in Orange County.

Reflecting on the past year, we have achieved significant milestones despite facing challenges. Notable accomplishments include celebrating our Family Resource Center's first year in Buena Park, which has had a lasting impact on the community.

We reaffirmed our dedication through our enhanced Program Pillars: Family Services, Food/Basic Needs, and Education/Workforce Development. We will expand family services to include additional mental health support, and our food distribution efforts will grow by creating a mini-market space to serve our families with added dignity. Our new first and second phase in 2024 of Emergency Rental Assistance in District 4 is addressing housing instability.

To prepare our community for a dynamic job market, we pivoted to aligning our programs with local schools, colleges, and adult education centers, and career technical education (CTE). Educational initiatives such as drone technology, entrepreneurship, the arts, AI, and free high school equivalency programs will be central to our strategy.

Celebrating 100 years of impact, we are filled with gratitude for our supporters, partners, and the resilient families we serve. This milestone is a testament to our collective achievements. Let us continue to build on this legacy, striving towards a future where every child and family in Orange County can achieve their full potential.

I also want to recognize the legacy of our past leaders and CEOs, specifically Cathy Seelig, who led Friendly Center with dedication for 25 years. Her contributions have been instrumental.

As the new President and CEO starting in December 2023, I am excited to lead us into this new chapter. I am grateful for the warm welcome I have received and am committed to working closely with all of you to further our mission. Together, we can achieve even greater things. OUR IMPACT

Over the past three years, the need in our community has steadily increased. Friendly Center has been there every step of the way, and with the continued support of our donors, we will keep helping the Orange County community.



households received food distributions, providing nutrition to **24,342** individuals and children.*



Households participated in our Case Management Program - a program designed to bring families back to stability. These families and individuals may have been referred to Friendly Center through Orange County Social Services due to a crisis they have experienced within the home. 73% of households have remained stable after completing the Case Management Program.



Children received a gift through the Holiday Toy & Gift Drive.

234,064 Pounds of food distributed in 2023



Thanksgiving dinners, feeding **2,834** individuals, fostering community bonds and ensuring joyful holiday celebrations and stronger families.



518 families received emergency food supplies, feeding **1,406 individuals**, including **621 children**, ensuring their nutritional needs were met.

192 families, including **537** individuals and **245** children, received hygiene items, promoting health, wellbeing, and dignity in our community.

Jennifer's Story

I was a prisoner of fear, trapped in a cycle of abuse. My breaking point came when my husband pulled a knife on me.

I silently suffered from the abuse of my husband for six years with my three children.

I didn't know how to make things better. It was difficult to see my kids struggling with our family being torn apart, on top of trying to make ends meet. Eventually I separated from my husband and got a restraining order, but he later convinced me to remove the restraining order and move back in.

That night he pulled a knife on me.

This was my breaking point. I knew I needed to leave and protect my children. I needed help. After separating again, I was referred to Friendly Center and that is when things changed for us. I met with one of Friendly Center's Family Support Advocates who immediately made me feel welcome and safe. She helped me develop a plan to help me move forward. We found an apartment that I could move to with my children, but it wouldn't be ready for a few days.

Friendly Center provided me with a motel voucher to stay somewhere temporarily until the apartment was ready. After the move, Friendly Center was there to help with beds for the kids and a dining table. Eventually, I started counseling at Friendly Center and joined a support group for women who were victims of domestic violence. I also continue to receive support with regular groceries and diapers.

Friendly Center offered us a lifeline.

Through their services, I found the strength to break free, to rebuild my life, and to rediscover my worth.

The continual increase in cost of living in Orange County has caused many struggling, working families to be on the brink of poverty. Reports show that 10.8% of children in Orange County are living below the poverty line, causing detrimental effects on children's physical and mental health and overall wellbeing of children. Research indicates the implications of poor academic achievement, abuse and neglect, behavioral, social and emotional problems, physical health issues, and development delays within children in poverty.






